#### ORDER:-

In the reference 1<sup>st</sup> read above, Ministry of Textiles, Government of India, New Delhi has accorded in principal approval to start INDIAN Institute of Handloom Technology in Telangana State.

2. In the reference 2<sup>nd</sup> read above, the Commissioner of Handlooms and Textiles and AEPs, Hyderabad has stated that during the review meetings held on 21.05.2024 and 26.07.2024, the Government has instructed to expedite the setting up of Indian Institute of Handloom Technology and to start the first year courses immediately in the current academic year i.e. 2024-25. Accordingly, the Commissioner of Handlooms and Textiles and AEPs, Hyderabad has submitted a detailed proposal for establishment of Indian Institute of Handloom Technology (IIHT) in the State as hereunder:

### I) Location of the Institution:

- The Development Commissioner for Handlooms, Ministry of Textiles, Government of India, New Delhi has accorded in principal approval to set up IIHT in Pochampally Handloom Park Pochampally Handloom Park, Kanumukkala (village), Pochampally (mandal) Yadadri-Bhongir district in the available of land of 26 Acres owned by Telangana State Handloom Weavers Cooperative Society (TGCO) Hyderabad.
  - Due to urgency and short time, the proposed Indian Institute of Handloom Technology (IIHT) is intended to be set-up in the campus in Sri Potti Sreeramulu Telugu University, Nampally, Hyderabad-on temporary lease basis until all relevant infrastructure as per norms are made available at the Handloom Park at Kanumukkala (Village), Pochampally (Mandal), Yadadri Bhongir district. The Class rooms and administrative activities will be taken up in the available space admeasuring of 5,000 SFT (approximately) in Sri Potti Sreeramulu Telugu University, Nampally, Hyderabad. Further Five type of Labs have to be setup to impart practical training to the students. Due to space constraints, these Labs will be established in the available space at Cellar portion in Chenatha Bhavan, Nampally, Hyderabad owned by the Handlooms & Textiles Department which is near by the proposed main campus i.e. Sri Potti Sreeramulu Telugu University, Nampally Hyderabad.

## II) Type of Course:

 Diploma in Handlooms and Textile Technology (DHTT) under the academic control of the Development Commissioner for Handlooms (DCH), New Delhi. • To commence the Diploma Programme of three years (6 Semesters) in "Handlooms & Textile Technology" this academic year, with an intake of 60 students for the first year as per IIHT/AICTE norms.

#### III) Admissions:

- Intake: 60 Seats per year and 180 students at the end of Third year.
- Time frame: 15<sup>th</sup> September, 2024.
  Method: By direct open notification.

#### IV) Faculty:

 The Faculty has to be recruited as per AICTE norms @ ratio of 1:25 which excludes Laboratory staff as detailed below:

# V) Development Commissioner for Handlooms (DCH) New Delhi overview:

Curriculum, Conduct of examinations and Issue of Diploma certificates will be taken care by the Development Commissioner for handlooms (DCH) New Delhi on par with other IIHTs in the Country.

#### VI) Formation of Executive Committee:

A committee with Nine (9) members has to be constituted with the following composition. The Executive Committee may be delegated with all the administrative, academic, financial powers to run the IIHT as per relevant statutory norms

- 3. Government after careful examination of the proposal hereby accord permission for the following:
  - i. For establishment of Indian Institute of Handloom Technology (IIHT) at Pochampally Handloom Park, Kanumukkala (village), Pochampally (mandal) Yadadri-Bhongir district in the available land of 26 Acres owned by Telangana State Handloom Weavers Cooperative Society (TGCO) Hyderabad on permanent basis.
  - ii. To set up the Indian Institute of Handloom Technology (IIHT) in Sri Potti Sreeramulu Telugu University, Nampally, Hyderabad on temporary basis until all relevant infrastructure as per norms are made available at the Handloom Park, Pochampally and also to set up Five type of Labs in the available space at Cellar portion in Chenetha Bhavan, Nampally owned by the Handlooms & Textiles Department to impart practical training to the students.
  - iii. To commence the classes for 2024-25 academic year from 15.09.2024.
  - iv. To recruit the staff as detailed at Para(2)(IV) above on outsourcing basis by open notification for the current academic year i.e. 2024-25, duly following Government guidelines.
  - v. To appoint the Additional Director, Handlooms & Textiles as Incharge-Principal to the proposed Indian Institute of Handloom Technology (IIHT) to take up the admissions and to run the institute as per the norms and recruit faculty.
  - vi. Constitute the Executive Committee with the powers and functions as delegated by the Government as detailed above at Para(3)(VI).
  - 4. The orders for sanction of budget shall be issued separately.
  - 5. The Commissioner of Handlooms and Textiles and AEPs, Hyderabad shall take further necessary action accordingly.
